THIS IS A JURIED CRAFT SHOW!

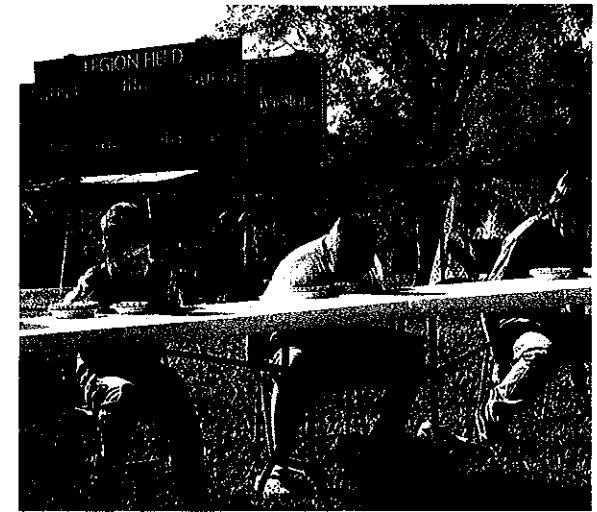
If you did not participate in the Kingston Country Fair in 2007, or you are adding a new craft, you must submit a minimum of four (4) photos of your craft. This may be in the form of pictures or 4 photos computer printed on a sheet of paper. Please enclose a self-addressed stamped envelope so that we may send you your acceptance letter and additional information. If you are denied entry, you will be called.

YOU MUST BE PRESENT FOR BOTH DAYS OF THIS EVENT, and stay the designated time for both days.

VENDORS ARE REQUIRED TO PROVIDE THEIR OWN TENTS, TABLES and chairs, and are also required **TO RENT BOOTH SPACE THAT CORRESPONDS OR IS LARGER THAN THE SIZE OF TENT BEING USED** i.e. tent size 10'x 12' - booth space rented must be 10'x 20'.
